- 1. The Executive Director, AIIMS Bilaspur (H.P.) reserves the right to vary the vacancies or cancel the exercise at any stage of the process without assigning any reason.
- 2. The maximum age limit for applying for the posts mentioned above on deputation is 56 years as of the last date of receipt of application. However, for the post of Medical Superintendent the maximum age limit is 58 years.
- 3. The initial period of deputation shall ordinarily be three years from date of appointment and the same will be regulated as per DoPT guidelines.

- 4. While forwarding their applications, Employer/Cadre Controlling Authority may ensure that the particulars of the candidates are verified and that they fulfil the eligibility conditions. Duly attested photocopies by competent authority of the applicant's up-to-date Confidential Reports (at least for the latest 05 years) may also be enclosed with the application. It may also be clearly stated that no vigilance/disciplinary proceedings are pending or contemplated against the candidates concerned. Application without vigilance clearance and ACRs/APARs Dossiers will not be considered. Supporting documents related to qualification, experience etc. may also be self- attested.
