Please note that it is the mandatory condition that all the participating Bidder/companies may participate and quote their prices for each and every Medical Gases and liquid nitrogen and also items mentioned in Annexure-B in this e-Tender, failing which their offer shall be summarily rejected & no further correspondence will be entertained.

Rate Contract items: Supply and Refilling of Medical Oxygen, Other Medical Gas Cylinders & Liquid Nitrogen

Period of Rate Contract: Two Years.

All India Institute of Medical Sciences (AIIMS) Bilaspur (Himachal Pradesh), an Institute of National Importance was officially approved, under Phase-V of the Pradhan Mantri Swasthya Suraksha Yojana (PMSSY), by Union Cabinet on December 04, 2019. The Institute is established over a span of about 247-acre (99.96 hectare) land on National Highway – 205 (Shimla-Kangra / Shimla Ghumarwin Road), in the village of Kothipura, District Bilaspur, Himachal Pradesh. AIIMS Bilaspur (H.P.) is set up with objectives of correcting regional imbalances in the availability of affordable/reliable tertiary healthcare services and also to augment facilities for quality medical education in the country.

On behalf of Executive Director, AIIMS, Bilaspur, H.P. invites online bids on CPPP (<https://eprocure.gov.in/eprocure/app>.) Portal under two bid system (Techno-Commercial Bid and Financial Bid) from interested, eligible and qualified manufacturer or their authorised distributors/dealers for **APPOINTMENT OF RATE CONTRACT FOR REFILLING OF MEDICAL OXYGEN, OTHER MEDICAL GAS CYLINDERS & LIQUID NITROGEN FOR TWO YEARS AT AIIMS BILASPUR, HIMACHAL PRADESH.**

1. The Tender shall be invited through CPPP Portal and any Corrigendum to the Tender Notice shall be issued in CPPP Portal only.
2. Tenders should be uploaded/submitted through CPPP Portal at <https://eprocure.gov.in/eprocure/app>. **Manual bids/Hard copy of the tender documents will not be accepted.**
3. Prospective Bidders are requested to view CPPP Portal/website regularly and tender documents may be downloaded from CPPP Portal <https://eprocure.gov.in/eprocure/app>.
4. Aspiring Bidders/Suppliers who have not enrolled/registered in CPPP Portal should enrol/register before participating through the website <https://eprocure.gov.in/eprocure/app>.
5. Tenderers can access tender documents on the website. Fill them with all relevant information and submit the complete tender document into electronic tender on the website <https://eprocure.gov.in/eprocure/app>.
6. Tenders and supporting documents should be uploaded through CPPP portal. Hard copy of the tender documents will not be accepted.
7. The Terms & Conditions stipulated in the tender form (MTF) shall prevail over the General Terms & Conditions (GTC) of CPPP portal.
8. Any fee claimed/charged by the CPPP portal shall be paid by the bidder. Non-payment of portal charges by the successful bidder would tantamount to resiling from the bid.

Bidders Eligibility & Qualification:

1. Bidders should be reputed manufacturers/authorised supplier of medical gases. Manufacturer/authorizer should have valid drug manufacturing license from concerned Drugs Controller as per Drugs & Cosmetics Act, 1940 & Rules framed there under.
2. Bidder must also possess requisite license from CCE under Explosive Act, 1884 and Gas Cylinder Rules 2016 or latest, along with its own full-fledged lab with chemist, in house facility for testing/trace impurities.
3. Bidder must also adhere to relevant provisions of Explosive Rules, 2016 or latest, Static & Mobile procure vessels (Import) Rules 2016 or latest by PESO, Govt. of India.
4. Manufacturer/Authorizer should have a Filling and Test certificate issued from Petroleum and explosive safety organisation (PESO) for examination and testing of cylinders (Attested copies of above certificate must be produced at the time of supply of the cylinders to the consignee site.)

Terms & Condition and Scope of supply: -

1. The bids are not transferable.
2. Bidders are not allowed to submit more than one bid for same/similar tendered item else all his bids shall be cancelled thereby resulting in disqualification in addition to suspension for two years.
3. Rates quoted should be inclusive of all applicable taxes, packing, forwarding, postage and transportation charges at AIIMS, Bilaspur (H.P.) (Site of installation/Use). **Rates should be mentioned both in figures and in words.**
4. The bidder should have suitable arrangements for medical oxygen, other medical gases & Liquid Nitrogen for emergency supplies after the receipt of intimation and round the clock on call phone number, service & mail ID for demand placement.
5. Once the cylinder supplied by bidder becomes empty, it will be their sole responsibility to collect empty cylinders immediately after they are informed, irrespective of the fact the cylinder belongs to bidder or to AIIMS Bilaspur (H.P.). No rental or extra charges will be paid for empty cylinders lying in AIIMS Bilaspur (H.P.) after they are informed.
6. As the firm is to ensure the fitness of the cylinder prior to the refilling to the required pressure, they shall be required to undertake internal examination and hydraulic testing of all the cylinders, but prior information is to be provided to In-charge Manifold, AIIMS Bilaspur (H.P.).
7. Tenders should be quoted only by the actual manufacturer or their authorized dealer/distributor, who are currently authorized by the manufacturer to supply the said refilling service for the **entire contract period**. The bidder is required to submit their authorization letter in support of their authorization by the manufacturer.
8. Firm must have registration certificates with validity of applicable drug license.
9. The bidder should also have proper arrangement for the testing and repairing of the cylinders required from time to time.
10. The rates quoted for repairing of the cylinders should also include the necessary repairs, etc (Annexure B) of cylinders during the contract period. Rates quoted to be frozen throughout the contract period, including period of extension if any.
11. Compressed gas cylinders under explosives Act 1981 (Certified by CCOEA Nagpur), expenditure for testing & certification will be borne by manufacturer/ authorized distributor of manufacturer.
12. **Guarantee Certificate:** -
The gases supplied under this tender shall be deemed to bear a warranty of the contractor against deterioration, defective material, workmanship and performance for a period of 12 months from the date of receipt by stores at AIIMS Bilaspur (H.P.). If during this period the stores supplies are found defective in performance or deteriorated, the contractor shall be responsible for all consequences.
13. The **Rate contract will be valid for Two years (02 Yr) from the date of finalization of tender.** Successful bidders would be bound to supply the gases even after completion of tenure on tender rates, terms & conditions **till the next tender/fresh arrangement are finalized**. Executive Director AIIMS Bilaspur (H.P.) reserves the right to terminate contract at any stage if supplies and performance found unsatisfactory on observation of user Department.
14. The bidder should also keep in mind while submitting the bid that **no extra charges payable towards to and fro transport of re-filled and empty cylinders during the contract period**, i.e. the rates quoted by the bidder should be inclusive of the freight of re-filled cylinders from the manufacturing/filling station to the client site (AIIMS, Bilaspur (H.P.) and also the freight charges of the empty cylinders from the client site to the filling station.
15. The firm should not demand separate security, caution money & rent/ maintenance charge, transport charges and holding charges on gas cylinders.
16. Refilled Gas cylinders shall be supplied by the manufacturer/authorised distributor of manufacturer depending on the day-to-day demand of Hospital (AIIMS Bilaspur (H.P.)).

17. Refill & supply of gases to AIIMS Bilaspur (H.P.), is a contract of regular and continuous nature, hence it is necessary that empty cylinders once received by the contractor, are serviced, filled and supplied as soon as possible.
18. Supply rate should include loading and unloading charges including any type of labour cost or any other charges. This will be applicable for cylinders provided by AIIMS Bilaspur (H.P.) and the manufacturer's/ bidder's own cylinder. Any other taxes/duties payable, should be mentioned clearly and separately.
19. Supply rates will not be increased during the contract period including in cases of escalated demands like in pandemic or in situations of decreased usage.
20. Storage facility (certified by PESO) of oxygen, nitrous oxide, and carbon dioxide cylinders must be there with the bidder at the time of placement of bid and its location should be in within 200 km radius of AIIMS, Bilaspur (H.P.)
21. Vendor will repair or replace the items **free of cost** on account of damage/theft of cylinders, fittings spares, valve caps etc. during transit for cylinders belonging to AIIMS Bilaspur (H.P.).
22. Cylinders of all gases are required to be tested (dissolved acetylene tested or hydraulically tested) periodically as per the gas cylinders Rule-1940. Responsibility for compliance with this rests with the contractor who will carry out examination/hydraulic test as may be required. A copy of the test report may also be provided to the AIIMS Bilaspur (H.P.).
23. Vendor will **deposit double the procurement cost** of cylinders lost or returned in irreparable conditions.
24. The contractor shall ensure the exact quantity of medical gases & Liquid Nitrogen as specified is being supplied after proper calibration of Cylinders, which shall be arranged by him failing which the supply will be rejected. All disputes shall be subject to the jurisdiction of courts in Bilaspur, Himachal Pradesh only.
25. Refill and Supply Rate should include loading and unloading charges including labour cost at factory site as well as Institute site. Separately any other taxes/duties payable should be clearly mentioned. The Institute shall bear any increase in the statutory taxes/duties (such as excise duty) only on the finished goods/product, which may become liable later during the period of contract. However, the Institute shall be entitled to the benefit of any decrease in the price on account of reduction or remission of excise duty, sales tax or any other statutory tax or duty which takes place during the period of contract. The agencies shall clearly specify the sales tax to be charged from the Institute.
26. The rates quoted should be justified as the lowest for and Govt. or Pvt. Hospital in India, If the price of any item is reduced due to any reason during the currency of the contract, the contractor will intimate the reduced price immediately and will charge as per the reduced rates.
27. Manufacturer/vendor has provision for tracking medical oxygen cylinder, other gas cylinder & liquid nitrogen in upstream and downstream movement (**optional**).
28. All cylinders are AIIMS, Bilaspur (H.P.) owned. A detailed inspection of the empty cylinders will be carried out by the contractor on receipt of the same at AIIMS Bilaspur (H.P.). In the event of any fitting and spares including valves, caps etc. found damaged or missing irrespective of the facts, whether damage of loss occurred at AIIMS Bilaspur (H.P.) the contractors are required to notify the gas manifold store before taking out the empty cylinders.
29. The record for supply and refilling shall be maintained by the both party ends (Supplier & Purchaser) through the Note/Supply Instruction and all entries should also be maintained in the respective Controlling Department Registers, so that the during cross examination of the Supplier Agency's Payment Claim, which is duly approved and forwarded for payment by the Controlling Department Authority (Manifold Department), the required shall be provided to the Stores/Accounts/Finance Department with all the required relevant details on account of supply and refilling (if required on demand) and Payment Claim of the supplier Agency shall be released by the AIIMS Bilaspur(H.P.) within 30 days period on each month basis **without dispute** during the Concurrency of the Annual Rate Contract.

30. **No minimum number of cylinders per trip will be demanded by the supplier.**

31. **Penalty Clause: -**

a) It will be the sole responsibility of the manufacturer/ authorised dealer/ distributor of manufacturer to refill and supply the cylinder within stipulated time frame, otherwise, the Institute may impose penalty at the rate of 5% of gas refilling price, per cylinder, per day. If the supply is delayed continuously 3-4 times, the contract is liable for Termination by serving 1 Month Notice. Consequently, the Performance Security Deposit shall be forfeited and the Agency/Contractor shall be blacklisted/Debarred.

b) Random sampling will be done at the Institute and pilferage or less quantity will be recovered at penal rate i.e., half of the supply rate.

32. **Proper record of day-to-day Medical Gases and liquids Nitrogen supply with instructions issued by the Competent Controlling Authority/Department (i.e., Engineering section along with MGPS, AIIMS Bilaspur, Himachal Pradesh should be maintained by the supplier and produced as and when required.**

33. **Delivery Period:**

The first Delivery Period is maximum 03 days and subsequently 24 hours from date of issue of Purchase Order/indent against the Rate Contract and if, it is not acceptable to Supplier, it may be intimated to the Purchase Officer within 12 hours from the date of issue of the Purchase Order, otherwise it will be assumed that the Purchase Order has been accepted. The date of delivery will be the date by when it is to be delivered at consignee site. In case of exigency, a shorter Delivery Period of 12 hours will be given.

SPECIAL CONDITIONS OF CONTRACT (SCC)

1. The firm must be manufacturer/ authorized distributor of medical gases and liquids supply i.e., medical oxygen, nitrous oxide, medical CO₂ and Liquid Nitrogen and the firm should hold valid manufacturing license for medical gases and liquids supply from the concerned Drugs Controller as per the provision of Drugs and Cosmetic Act,1940 and Rules there under.
2. Firm, should have a valid license for storage filling and cylinder testing and other requisite license if any issued by CCE Nagpur as statutory requirement.
3. The tenderer has to ensure compliance of Rule 3 of the Gas Cylinder Rules, 2016 or latest and timely obtain necessary filling permission from the chief controller of explosives under Rule 45 while supplying the cylinders for filling of compressed cryogenic gases, if required.
4. Should have full facility for testing and logging for impurities in each batch of manufactured gas & cylinders.
5. All cylinders should be tested and specified for filling of medical gases by CCOE approved tests.
6. Dedicated gas cylinders should be used for medical gases. These cylinders are specially treated to fill medical grade gases.
7. In house facility for regular testing & certification of cylinder for tare weight, Hydraulic pressure tests etc. as per norms for compressed gas cylinders under Explosives Act 1884 and Gas Cylinder Rules 2016 or latest, expenditure for testing & certification will be borne by company. Bidder must have its own fully fledged lab with testing facilities.
8. The firm should maintain colour code of all medical gas cylinders & liquid Nitrogen.
9. Cylinder should mention date of last testing & due date of next testing. (on cylinder neck)
10. The firm should have adequate & efficient safe transport in order to ensure timely supply of medical gases and liquid Nitrogen supply.
11. The rates should include all charges up to delivery at the earmarked place in the Institute. The firm should not demand separate security, caution money & rent/ maintenance charge, transport charges and holding charges on gas cylinders. All charges should be included in the other charges in the price bid.
12. The firm should supply and station the cylinders to the store area of the manifold room.
13. The firm will be responsible for routine check and maintenance at no extra cost.
14. The firm should ensure refilling and supply of all type of cylinders A, B, D/Bulk, aluminium type A cylinder (MRI compatible) and bottle type for medical gases and liquids supply (O₂, N₂O, CO₂, Liquid Nitrogen).
15. Supplier is bound to supply /refill the cylinders during the validity of tender at the approved rates. The validity of the tender will be for a period of Two years from the date of finalization of the tender. The rates quoted should be certified as the lowest quoted for any institution in India in the last 2 years. If the price of any item is reduced due to any reasons during the validity of the tender, the same should be intimated to AIIMS Bilaspur (H.P.) and the benefit of reduced rate should be passed to AIIMS Bilaspur (H.P.).
16. **Note:** Representative from the hospital/Institute may visit the suppliers place from time to time for checking gross weight, tare weight and net weight of the cylinders. The supplier shall have to provide necessary information and shall cooperate in this matter, no additional charges will be payable from hospital.
17. For N₂O and Carbon Dioxide and liquid nitrogen cylinder will be checked by weighing on kg basis and for O₂, the cylinder pressure should be more than 135-bar in winter and more than 140-bar in summer. Cylinder showing less weight or pressure shall be returned and the vendor shall replace them with adequately filled cylinders at their own cost.
18. The supplier should be willing to render assistance round the clock including holidays and in case of Emergencies.
19. The supplier will keep 50-60 D-type filled cylinders of Medical Oxygen at the AIIMS Bilaspur (H.P.) hospital premises / stores at all times.
20. The rates quoted by the Contractor shall not, in any case exceed the controlled rate, if any, fixed by the Government at the time of supply to the Institute. If the rate quoted exceeds the

controlled rate or rates permissible under the Hoarding and Profiteering Prevention Ordinance 1943 as amended from time to time, the Contractor will specifically mention this fact in his tender along with reasons for having quoted such higher rate. The Executive Director at his discretion will, in such case, exercise the right of revising the price at any stage so as to conform to the controlled rate or the rate permissible under the 'Hoarding and Profiteering Prevention Ordinance 2000'. The discretion will be exercised without prejudice to any other action that may be taken against the Contractor.

Other Terms and Condition of Tender

Earnest Money (EMD)

- (i) Each tender must be accompanied by an Earnest Money @5% value of contract. Which must be submitted electronically through NEFT/RTGS/DD/FD/Banker's cheque other electronic means by the tenderers.
- (ii) The Tenderer shall be permitted to bid on the express condition that in case he resiles, or modifies his offer, or terms & conditions thereof, after submitting his tender, for any reason whatsoever during the tender process, or any of the information furnished by him/her is found to be incorrect or false, the Earnest Money Deposited by him shall stand forfeited, without prejudice to any other rights and remedies of the AIIMS Bilaspur(H.P.) on under the Contract and Law, and the Tenderer will be liable for any loss suffered by the AIIMS Bilaspur(H.P.) on account of its withdrawal/modification etc. besides forfeiture of EMD. He will also be debarred from participating in any other Tender Enquiry with AIIMS for a period of two years.
- (iii) Earnest Money will be returned to all unsuccessful tenderers within a period of 15 days from the date of disqualification in the case of all Tenderers whose Technical Bids are disqualified, and within a period of 30 days from the date of issue of the acceptance letter in the case of all other Tenderers and to a successful Tenderer, after he has furnished the Security Deposit, if he does not desire the same to be adjusted towards the Security Deposit. No interest shall be payable on Earnest Money, in any case.
- (iv) Micro & Small enterprises (MSEs) will be exempted from payment of Earnest Money Deposit (EMD).
- (v) The Startups are exempted from the payment of Earnest Money Deposit (EMD) on submission of proof of their being registered with the agencies prescribed by Govt. of India.

Performance Security Deposit

- (i) The successful Tenderer shall furnish, within 3 (three) working days of acceptance of his tender, a Security Deposit for the due performance of his obligations under the contract and validity of PBG will be 26 months.
- (ii) A sum equivalent to 05% of the value of the Contract submitted in the shape of FDR/BG duly pledge in favour of Executive Director, AIIMS BILASPUR (H.P.).
- (iii) The Security Deposit furnished by the Tenderer will be subject to the terms and conditions given in the Tender and AIIMS BILASPUR(H.P.) will not be liable for payment of any interest on the Security Deposit.

- (iv) In the event of the Tenderer's failure, after the communication of acceptance of the tender by AIIMS BILASPUR (H.P.), to furnish the requisite Security Deposit under by the due date Contract shall be summarily terminated besides forfeiture of the Earnest Money and the AIIMS BILASPUR (H.P.) shall proceed for appointment of another contractor. Any losses or damages arising out of and incurred by AIIMS BILASPUR (H.P.) by such conduct of the contractor will be recovered from the contractor, without prejudice to any other rights and remedies of the AIIMS BILASPUR (H.P.) under the Contract and Law. The contractor will also be debarred from participating in any future tenders of the AIIMS BILASPUR(H.P.) for a period of two years. After the completion of a prescribed period of two years, the party may be allowed to participate in the future tenders of AIIMS BILASPUR(H.P.) provided all the recoveries/ dues have been affected by the AIIMS Bilaspur (H.P.) and there is no dispute pending with the contractor/party.
- (v) If the successful tenderer had previously held any contract and furnished security deposit, the same shall not be adjusted against this tender and a fresh security deposit will be required to be furnished.

Submission of Tender: -

- a) The tender shall be submitted online in two parts, viz., technical bid and price bid.
- b) Tender Document (except price bid) along with supporting documents duly signed have to be scanned and uploaded at the requisite places in the CPPP Portal.
- c) Successful tenderer will also submit a **physical copy of complete signed Tender Form** for the purpose of record before issue of award of the contract letter.
- d) The supporting documents shall be scanned and uploaded by Tenderer clearly, neatly and accurately in readable format. Any alteration, erasures or overwriting on the supporting documents should be duly initiated by the authorized signatory.
- e) Tenders not accompanied by all the Schedules/Annexures intact and duly filled in and signed will be rejected.
- f) It should be clearly understood by the Tenderer that no opportunity shall be given to them to alter, modify or with-draw any offer at any stage after submission of the tender.
- g) Any attempt by tenderer to change the format of any of the supporting documents of the T&C while uploading or any attempt to tinker with the software of the portal will render his tender liable for cancellation.

Corrupt practices:

Canvassing on the part of, or on behalf of, the Tenderer will also make his tender liable to rejection.

AIIMS BILASPUR (H.P.) reserves the right to reject any or all the tenders without assigning any reason and does not bind it-self to accept the lowest or any tender. The successful Tenderer will be intimated of the acceptance of his tender by a letter/telegram/fax/email.

In case of any clear indication of cartelization, AIIMS BILASPUR(H.P.) shall reject the tender(s), and forfeit the EMD.

If the information given by the Tenderer/Party in the Tender Document and its Annexures & Appendices is found to be false/incorrect or has violated/breached any of the terms & conditions of the contract, at any stage, AIIMS BILASPUR (H.P.) shall have the right to disqualify/summarily terminate the contract, forfeit EMD/SD/BG, make good any other losses caused to the AIIMS BILASPUR (H.P.) and debar the party for two years, without prejudice to any other rights that the AIIMS Bilaspur (H.P.) may have under the Contract and law.

Definitions:

- i. The term 'Contract' shall mean and include the Invitation to Tender incorporating also the instructions to Tenderer, the Tender, its Annexures, Appendices, Acceptance of tender and such general and special conditions as may be added to it.
- ii. The term 'Contractor' shall mean and include the person(s), Firm or Company with whom the contract has been placed including their heirs, executors, administrators and successors and the permitted assigns as the case may be.

Parties to the Contract:

(a) The Parties to the contract are the contractor and the AIIMS BILASPUR, HIMACHAL PRADESH.

(b) The person signing the tender or any other documents forming part of the tender on behalf of any other person or a firm shall be deemed to warrant that he has authority to bind such other person or the firm as the case may be in all matters pertaining to the contract. If at any stage it is found that the person concerned had no such authority, the AIIMS BILASPUR HIMACHAL PRADESH may, without prejudice to other civil/criminal remedies, terminate the Contract and hold the signatory liable for all costs and damages.

Constitution of Contractor:

(a) Contractor/shall, in the tender, indicate whether he/ they is/are a Sole Proprietary Concern, or Registered Partnership Firm, or a Private Limited Company, or a Public Limited Company incorporated in India. The composition of the partnership, or names of Directors of Company, as applicable, shall be indicated. The Contractor shall also nominate a person for the active management and control of the work relating to the Contract during the tenure of the Contract. The person so nominated shall be deemed to have full authority from the Contractor in respect of the Contract and his acts shall be binding on the Contractor.

Subletting: -

The Contractor shall not sublet, transfer, or assign the Contract, or any part thereof.

Bribes, Commission, corrupt gifts etc.

An Act of bribe, gift or advantage, given, promised or offered, by or on behalf of the Contractor, or any one of their partners/Directors/Agents or officials, or any person on his or her behalf to any officer, officials, representative or agent of the AIIMS BILASPUR(H.P.), or any person on his or their behalf, for showing any favour or forbearing to show any disfavour to any person in relation to the Contract, shall make the Contractor liable for termination of this Contract or any other Contract with the AIIMS BILASPUR(H.P.) and the contractor shall be liable to reimburse the AIIMS BILASPUR(H.P.) of any loss or damage resulting from such cancellation.

Period of Contract:

AIIMS Bilaspur (H.P.) reserves the right for period of Contract will be for Two years.

Foreclosure

The Institute may discontinue the contract at any point of time, without assigning any reason for the same, by giving one month notice before the intended date of discontinuation and will not be liable to any charges or compensation payable to the Service Provider or any other person. The Service Provider may discontinue the contract at any point of time, by giving a notice at least 90 days before the intended date for discontinuation. However, it will lead to forfeiture of the Performance Bank Guarantee deposited, in case of discontinuation without a notice or a notice less than 90 days prior to the intended date of discontinuation. The Institute will have the right to claim damages and recover them from the Service Provider, in addition to forfeiting the Performance Bank Guarantee of the Service Provider.

- a) The contract will be governed by the laws of India for the time being in force.
- b) In case of any dispute arising out of and touching upon the contract, the same will be first referred to the Executive Director, AIIMS Bilaspur (H.P.) with a view to settle the disputes.
- c) The results of technical evaluation will be uploaded on the CPPP Portal. In case there are technically disqualified bidders, the reasons for disqualification will be uploaded and price bid shall be opened only after 2 (two) working days. If any of the bidders is disqualified, he may submit grievance only through CPPP portal within two working days from the date of disqualification. **However, no new documents will be accepted.** In case of receipt of grievance, Executive Director AIIMS Bilaspur (H.P.) will redress the grievance by passing Speaking Order within three (3) working days after which the price bid will be opened.

Tender Currencies:

The bidders are required to quote in Indian Rupees only.

Payment Terms: -

Legal Jurisdiction: -

The Courts at Bilaspur (H.P.), Himachal Pradesh alone and no other Court will have the jurisdiction to try the matter, in case of dispute or reference between the parties arising out of this tender/supply order/contract.

Dispute Resolution: -

- a) Any dispute and or difference arising out of or relating to this service contract will be resolved through joint discussion of the authorized representatives of the concerned parties. However, if the disputes are not resolved by joint discussions, then the matter will be referred for adjudication to a sole Arbitrator appointed by the Executive Director, AIIMS, Bilaspur (H.P.).
- b) The award of the sole Arbitrator shall be final and binding on all the parties. The arbitration proceedings shall be governed by Indian Arbitration and Conciliation Act 1996 as amended from time to time.
- c) The cost of Arbitration shall be borne by the respective parties in equal proportions. During the pendency of the arbitration proceeding and currency of the service contract, neither party shall be entitled to suspend the work /service to which the dispute relates on account of the arbitration and payment to the service provider shall continue to be made in terms of the service contract. Arbitration proceedings will be held at Bilaspur (H.P.) only.

LIQUIDATED DAMAGE/DEMERGE: -

The time for the date of delivery/ dispatch stipulated in supply order shall be deemed to be the essence of the contract and if the **supplier fails to deliver any consignment within the period prescribed for such delivery in the supply order, liquidated damages may be deducted from the bill @ 0.5% per week subject to maximum of 10% of the value of the delayed goods or services under the contract.** The competent authority of the institute may also cancel the supply at the cost & liability of the supplier. In such a case, bid security of the supplier shall stand forfeited.

RISK PURCHASE:

If successful tenderer fails to supply material within the stipulated delivery date or material supplied other than specification specified in our Tender Documents, AIIMS Bilaspur reserves the right to terminate contract for that item(s), forfeiture of Performance security deposit and to procure same or equivalent material from alternative sources at the vendor's risk, responsibility and cost. Any extra cost incurred in the procurement of the material from alternative source will be recovered from the Performance Security Deposit / Bank Guarantee and pending Bills of existing firm and if the value of the materials under risk purchase exceeds, the amount of Security Deposit and / or Bank Guarantee and Pending Bills, the same may be recovered, if necessary, by due legal process or black listing of the firm depending upon the circumstances of the default/merit of the case.

NO HIKE IN PRICES DURING VALIDITY OF CONTRACT & ITS EXTENSION (IF ANY): -

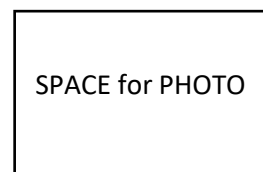
