NOTICE INVITING QUOTATIONS


Sealed quotations are invited by the undersigned on behalf of the Executive Director, AIIMS Bilaspur HP from eligible specialized agencies dealing in Supply and Installation of **Outdoor LED Display**. Sealed quotations in single envelope duly super subscribed at the top of envelope as "Quotation for:- **Supplying and installation of Outdoor LED Display on rental basis for Annual Day at AIIMS Bilaspur H.P.**" The envelop contains EMD, documents required and Price on BOQ sealed in separate envelop shall be received upto 02:30 PM on 27/09/2025 in the Engineering Section, Ground Floor Hospital Block D, AIIMS Bilaspur HP and **Opened at 03:00 PM** on same day in the presence of the Bidders or their representatives who may like to be present at that time.

TERMS AND CONDITIONS:

1. Earnest Money amounting to Rs 5000/- in the form of Demand Draft or Pay order or Banker's Cheque or Deposit at Call Receipt or Fixed Deposit Receipt (drawn in favour of **Miscellaneous Fund All India Institute of Medical Science Bilaspur Himachal Pradesh**) shall be submitted along with quotation. Quotations **not accompanied** by the required EMD **shall be summarily rejected and will not be considered under any circumstances**.
2. Validity of the rates shall be 60 days from the last date of submission.
3. To become eligible, the bidder must submit the following documents along with prices.
 - i. Profile- Name & full address of the firm.
 - ii. Copy of Valid Certificate of Registration for GSTIN.
 - iii. Copy of PAN.
 - iv. Self -declaration that the firm is not debarred by any department of state/ center Govt.
4. The bid submitted shall become invalid if:
 - a. The bidder is found ineligible.
 - b. The bidder does not submit all the documents as stipulated above.
5. If a bidder does not quote any rate in figure and words, the bid shall be treated as invalid and will not be considered as lowest bid.
6. Conditional quotation(s) not on prescribed form are liable to be rejected.
7. The competent authority/undersigned in AIIMS Bilaspur HP reserves the right to accept/reject any or all the quotations without assigning any reasons.
8. The prices quoted should be inclusive of all taxes including GST and freight charges as nothing is to be paid extra.
9. All material to be used on the work will have to be got approved from the Committee members before installation.
10. If there is any ambiguity between the rate quoted in figures and in words, the rate quoted in words shall be treated as final.
11. Venue for quotation opening shall be in the Office of DDA, Admin Block, AIIMS Bilaspur H.P.


12. No revision of rates will be accepted at any stage.
13. Price format/BOQ attached. The total cost must be quoted in both words and figures (over writing not allowed). Selection will be made purely on the basis of lowest price quoted by firms.
14. No advance payment shall be made to the concerned party and the operator has to ensure security and safety of his equipments himself. **100%** payment shall be released after the satisfactory performance of the event.
15. If any bidder withdraws his quotation or makes any modification in the terms & conditions of the quotation which is not acceptable to the committee or refuse to execute the work, then the institute shall without prejudice to any other right or remedy, be at liberty to forfeit 100% of the earnest money absolutely irrespective of letter of acceptance for the work is issued or not.
16. Intending bidders are **strongly advised to inspect and examine** the site and its surroundings before submitting their quotations. Bidders should **satisfy themselves** regarding:
 - The nature of the ground conditions (as far as practicable)
 - The form and condition of the site
 - Access and logistics for transportation and installation
 - Any accommodation or storage requirements
 - All other factors or conditions that may affect the execution of the work
17. It shall be deemed that the bidder has **full knowledge of the site conditions**, whether the site is actually inspected or not, and that their quote reflects full consideration of all such factors.
18. **No additional claims or charges** shall be entertained on account of any misunderstanding, lack of information, or failure to inspect the site prior to bidding.


