QUOTATION NOTICE

Sealed quotations are invited from registered stockists/ distributors/ manufacturers having GST No. / for Supply of items as per the detailed specifications (Annexure-1). Sealed Quotations in a single envelope duly super subscribed at the top of the envelope as "**Quotation No. AIIMS/BLS/Patho/2024/NIQ/07 for the supply of Items for Pathology Department due date 22/03/2025**" containing both the "Technical Bid" and "Price Bid" (in two separate envelopes) may be submitted so as to reach on or before **22/03/2025 up to 05:00 P.M** in Department of Pathology, B1-Academic Block, AIIMS Bilaspur, Kothipura, Bilaspur, Himachal Pradesh PIN-174037. Bidders can quote for one or all the items. Late bids will not be considered. The bids shall be opened in the presence of duly constituted purchase committee. For the purpose of technical evaluation, the bidder is required to submit the following documents.

Technical Bid:

1. Profile-Name & Full Address of the firm & year of establishment.
2. Copy of permanent GST registration certificate.
3. Copies of supply orders secured during 2022-23 and 2023-24 for the similar products.
4. Self-declaration that the firm is not debarred by MoHFW or Department of Commerce.
5. Full description, make and quantity of the item must be mentioned in the quotation.
6. Technical Evaluation will be based on total value wise.

In case the bid is "Not Qualified" on technical grounds, the financial bid in respect of that item will not be considered.

Financial Bid: The Rates and total cost must be quoted in both words and figures (overwriting not allowed). Selection will be made purely on the basis of lowest price quoted by technically qualified firms. Validity of the quotation should be for a minimum period of 90 days in case discrepancy between unit price & total price, the unit price shall prevail.



1	Bone Cutter	01 NOS

- Used for cutting bone specimens and amputation specimens of big size
- Table made of thick stainless steel sheet with heavy axle to aid in firm and smooth movement
- Total table travel is about 124 cm. The size of the extension table should be about 45x76 cm.
- The size of the wheel should be about 45 cm. Total height not more than 170cm
- To be supplied with one blade, starter, electric cord, and hospital-grade plug and spare accessories
- The thickness of the bone cutter sections should be adjustable depending on size and requirements
- Should have bone dust collector unit and safety hood
- The weight of the machine approximately 350-450 kg and the working surface is divided into two halves with one half fixed and the other is capable of sliding to and fro.
- Bone Pusher, portioning device, and blade guard should be provided
- Detachable scrap pan and blade scrapper
- High speed self-ventilated motor
- Low voltage NVR Safety device (24V), with start and stop buttons.
- Cutting speed should be 15 m/sec.
- Blade Length should be 1650mm
