**NOTICE INVITING QUOTATION**

**Supply of SKIN GRAFTING MESHER in the Department of Burns and Plastic Surgery**

Online Quotation are invited from registered stockists / distributors / manufacturers having GST No. for the Supply of **SKIN GRAFTING MESHER** in the Department of Burns and Plastic Surgery as per the detailed specifications (Annexure-A). quotation should be emailed to dr.navneet.plasticsurgery@aiims.edu.in.

Quotation received in any other mode [other' than online mode] shall not be entertained.

**Procedure for submission of quotation:**

Quotation is to be submitted as Separate pdf document of technical and financial bid. Both the documents should be PASSWORD protected. Both the files should be labelled as "**Quotation No. AIIMS-BLS/B&PS/2024/ NIQ/40 {technical bid}**" and "**Quotation No. AIIMS-BLS /B&PS/2024/NIQ/40 {financial bid}**". Due date of the opening of the technical bid shall be informed through email. The bids shall be opened in the presence of duly constituted local purchase committee.

Last date for the receiving the online quotations shall be 07/01/2025 till 5pm. NO quotation shall be entertained after the passage of last date and time.

For the purpose of technical evaluation, the bidder is required to submit following documents.

**Technical Bid:**

1. Profile-Name & Full Address of the firm & year of establishment.
2. Copy of permanent GST registration certificate.
3. Turnover for last two years (2021-22 & 2022-23).
4. Self-declaration that the firm is not debarred by MoHFW or Department of Commerce.
5. Full description, make and quantity of the item must be mentioned in the quotation.
6. Technical Evaluation will be based on total value wise

In case the Technical Committee rejects a sample (if asked for) or the bid is "Not Qualified" on technical grounds, the financial bid in respect of that item will not be considered.


**Financial Bid:** The rates and total cost must be quoted in both words and figures (over writing not allowed). Selection will be made purely on the basis of lowest price quoted technically qualified firms. Validity of the quotation should be for a minimum period of 90 days in case discrepancy between unit price & total price, unit price shall prevail


Other terms and conditions will be as follows: -

1. Supply will be F.O.R. at AIIMS-Bilaspur
2. Supply will have to be arranged within 15 days from the issue of supply order. Delayed supplies beyond 15 days from the date of Supply Order will be subject to LD @0.5% per week or part thereof, on the contract price subject to maximum of 10% of contract price beyond which the supply order will be liable to be cancelled.
3. Vendor has to provide physical demonstration of the equipment if asked for by the committee.
4. The Institute reserves the right to reject the goods if the same are not found in accordance with the specifications approved/ asked for. In case there is a short/defective supply, the firm will be informed and the defective material will be lifted from the concerned department/ Store by the supplier at their own cost within two weeks' period. The Institute will not bear any expenses on this account.
5. Bidder is required to quote rate of 100% items.
6. Part supply will not be accepted.
7. No revision in rate (on higher side) will be accepted at any stage.
8. The firm shall not assign or sublet the work/job or any part of it to any other firm.
9. Billing will be in the name of Executive Director, AIIMS-Bilaspur. Payment will be made after the item has been received, inspected & accepted. No advance payment will be made at any stage.

### Technical specifications- Skin graft Mesher

- Expansion ratio, 1.5:1 – 4:1
- Simple operation by knob or ratchet; these should be exchangeable
- Device can be totally immersed in cleaning solutions and steam- or gas sterilized
- Integrated comb mechanism which prevents the skin from sticking on the expander roller
- Includes Mesher case, width plates, ratchet handle, wrench, and manual - Graft carriers
- Instruments should have at least 1-year manufacturer's warranty for any manufacturing defects.
- Products should be certified from US-FDA/EU-CE/CDSCO/BIS approved as applicable, the Certificate to this effect should be attached
