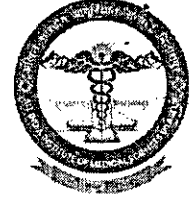



1. Candidate who has been considered provisionally eligible due to non-submission of requisite documents, as indicated against their name is granted a period of **one week** to submit the required documents. Failure to do so within the stipulated time will lead to cancellation of their candidature for the said posts. Eligible/Provisionally eligible candidates who have been working or employed shall submit relieving order from their current employer at the time of joining, failing which their candidature and letter of offer of appointment will be treated as cancelled and joining will not be allowed/accepted.
