3. Candidates shall bring following documents with them in original as well as one set of copy.
- Xth marksheet/certificate for proof of date of birth.

- ii. BSc (Nursing) degree from a recognized university/institution, if applicable.
 - iii. Sister Tutor's Diploma with registration as Nurse and Mid wife, if applicable.
 - iv. Three years' experience certificate in a teaching institution.
 - v. NOC and Vigilance clearance certificate from the employer in case of serving government employees.
 - vi. Admit card earlier brought by the candidates for screening test dated 10.05.2026.
 - vii. Caste/Category certificates as per advertisement.
4. It is clarified that the candidature of the applicants shortlisted is subject to the fulfillment of eligibility, age or any other criteria as per provisions of Recruitment Rules 2015 for the post of Tutor/Clinical Instructor and terms & conditions of the advertisement.
5. Only candidates whose claims/details are satisfactorily verified by the Document Verification Committee, constituted for the said purpose, will be allowed to appear for written test and interview. The candidature of such applicants whose details remain unverified satisfactorily may be treated as cancelled or provisionally eligible subject to fulfillment of stipulated conditions before issuance of appointment letter within stipulated time. Failure to meet the stipulated conditions within stipulated time shall result in cancellation of candidature.
6. **The written examination and interview will be of 60 and 40 marks respectively. Details of written examination are as under –**

7. In connection with the interview, the candidates shall bring original documents/certificates to substantiate their qualifications, experience and achievements including academic or any other, i.e. diploma/registration certificate/degree/post-graduate degree/PhD degree/research papers etc.
8. **The final merit list will be prepared based on the total marks secured in written test and interview. Tie-breaking rule will be as under for the purpose –**
- a. *First by marks in written examination, candidate with higher marks in written examination will be placed higher in merit;*
 - b. *If not resolved by (a), by using date of birth with older candidates placed higher.*
9. The entire process may last for two days. Accordingly, candidates are advised to plan their stay at Bilaspur (HP). No TA/DA will be paid by the institute for the purpose.

10. In case of doubt over interpretation of rules or terms & conditions of the advertisement, the decision of the Selection Committee shall be final.
